Agent IDX usage limit default is 5,000/mo. Extra block of 1,000 units add \$10/mo. Small Office IDX usage limit default is 10,000/mo. Extra block of 2,000 units add \$20/mo. Large Office IDX usage limit default is 20,000/mo. Extra block of 15,000 units add \$50/mo.
